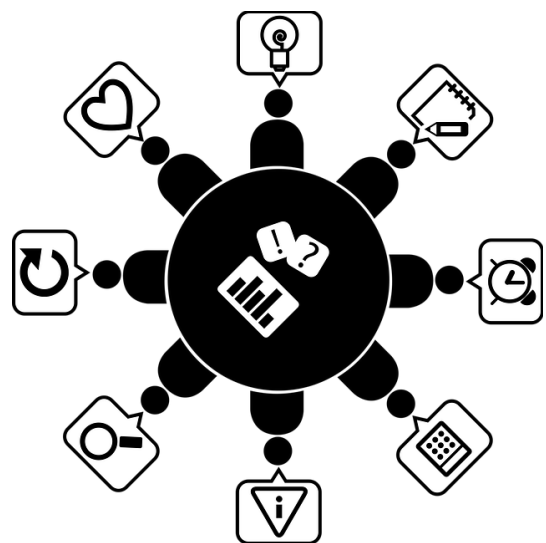

Pre-Sale and ICO Summary

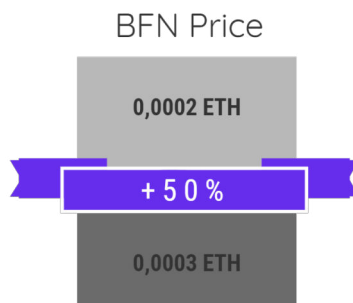

The „Soft Cap” means the minimum amount of raised ETH needed to fund the BlockFollow project. „Hard Cap” is the maximum amount of BFN can be sold at a phase. 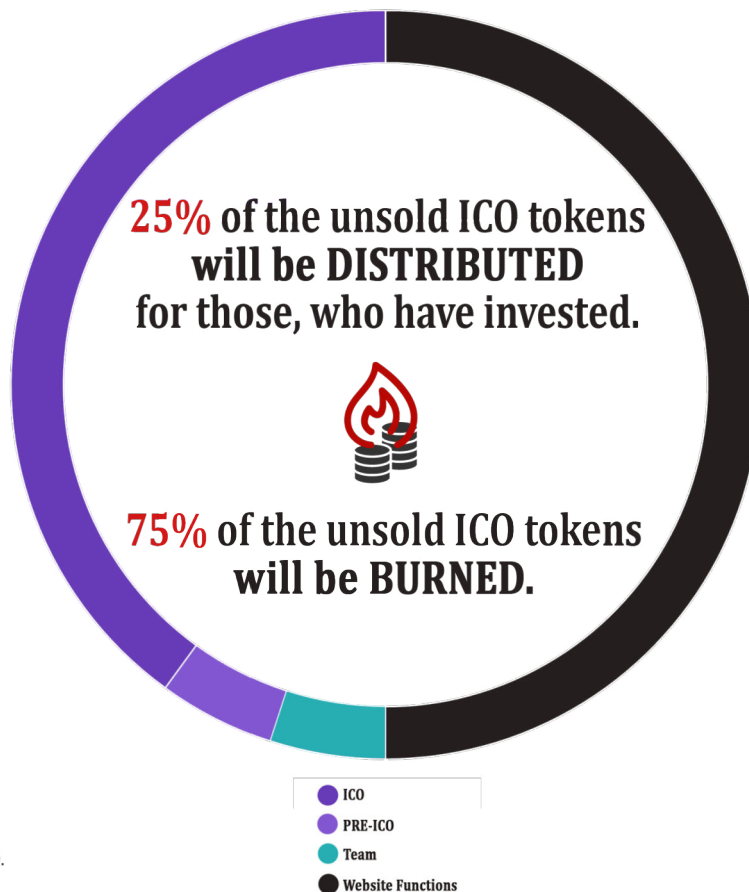

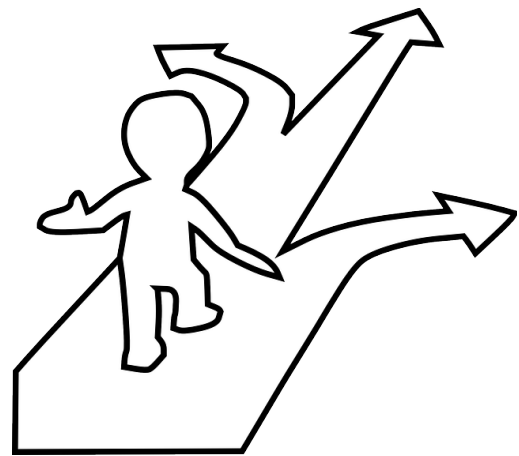

The Problem

We are in the middle of a digital revolution. Centralized proprietary services are being replaced by decentralized ones. Blockchain technology offers possibilities we have never seen before. In the past years, Bitcoin was seen as a Ponzi, then as an enemy of the current, classic monetary system. It took a few years for the people to realize, how great potential it has. The money is pouring into the coins, and media started to talk about it. Banks are searching for ways to use the blockchain, CME launched Bitcoin Futures trading, it's getting recognized and accepted around the globe.

Still, cryptocurrencies are unregulated and very fragile. A fake rumor can make a currency drop 30-50% of its value, if not more. There are couple of reasons: market is still relatively small, so its easy to manipulate (for example, dotcom was 6.7 trillion dollars, when it popped); people don't know, what they are investing in (they might be inexperienced in trading, following someone); last but not least, it is



hard to gather information about a project and realise its advantages for someone, who has little to no technological knowledge. In the past years only crypto-belivers was trading. Now even our grandmothers are considering buying bitcoin. This grows FUD, that can cause a bubble.

There isn't a gateway yet, that makes cryptocurrencies an everyday payment method and a long-term store of value. For an avarage person, it is even hard to purchase their first Bitcoin, Ethereum and I didn't even mention the another alternative coins so far. Currently only a small percentage of humanity knows about cryptocurrencies, and even less uses it. Our task to make them understand it's importance and help aid them from the first steps.

BlockFollow Network (BFN) Token Specs and Implementation

„BlockFollow Network” (shorter term: BFN) is the name of the currency we plan to distribute in order to make our services work. It is being developed, tested and deployed by our partner, the Espeo Software. BFN will be implemented on the public Ethereum blockchain and adhere to the ERC20 protocol. This makes MyEtherWallet, Mist and other Ethereum wallets compatible with our token. BFN will have a limited max supply of 150.000.000 (depending on the ICO, the supply could be in between the 100.687.500-150.000.000 range). Maximum 45% will be distributed under the ICO, the rest 55% will be used by the BlockFollow services.

BFN cannot be acquired directly by fiat money. Investors will have to use Ethereum to buy BFN token. The pre-ICO and ICO price is fixed. Between February 24th, 2018 and March 10th, 2018 early investors will get 50% more token. The pre-ICO exchange rate is 1 ETH = 5000 BFN (0.00020 ETH / 1 BFN). In the ICO-phase, the price will increase to 1 ETH = 3333 BFN (0.00030 ETH / 1 BFN). The crypto price volatility has zero impact on the price or token supply.

As the platform will provide a passive income after the official release for those, who hold at least 5000 BFN, it is recommended to be kept on the web/desktop/mobile wallet. 50% of house income will automatically be shared among the investors. BFN will support the website functions and transactions. In the near future, we plan to open a built-in exchange with trading pairs, that will use our token, generating bigger volume. To make BFN value independent of BTC and ETH volatility, we plan to open USD <-> BFN and EUR <-> BFN trading at the same time as we open the exchange.

The Future

The future depends on YOU, the pioneer of a new monetary system. We are open to great ideas.

Q1 2018 – The Beginning

The first quarter of 2018 will be crucial. The team will focus on making the pre-ICO and ICO successful, to have enough funds for the project. With your support, we will achieve it.

Pre-ICO

We launch our marketing campaign and start advertising 2-3 weeks before the Pre-ICO begins. On 24th of February, the crowdfunding will begin with a reduced price (0,0002 ETH / 1 BFN), ongoing for 2 weeks. The maximum distribution will be 7.500.000 BFN. It's a limited amount and will never increase. If that amount will be sold out before the official end of the pre-ICO, that won't change the starting date of the ICO. If not all BFN will get sold during the 2-week term, the leftover will be rolled to the ICO-phase.

ICO

The official starting date is March 11th, 2018. This phase will last for maximum 4 weeks depending on the success and will be sold at the normal price (0,0003 ETH / 1 BFN). The maximum distribution will be 60.000.000 BFN. It's a limited amount and will never increase. If not all BFN will get sold during the 4-week term, the 25% of leftover will be distributed to our investors, and the 75% will get burned.

Website Alpha

The development won't stop under the crowdfunding. We plan to release the alpha version of the BlockFollow in the late Q1 2018. It will have reduced functionality, but registration will be opened for a few selected previous investor to help to test our features. To tailor our services to your needs, we will ask for your feedback questions on each.

Q2 2018 – The Progress

The second quarter of 2018 will mean a full-time development effort for the BlockFollow team. After getting feedback from the Alpha, we can modify and make progress on our services. After a successful ICO, we can afford to rent or buy an office to make our everyday production better. Apart from the team that Espeo Software provides, we will hire other developers, customer service assistants, to have the capacity we need to deliver BlockFollow. After the end of the ICO, we will hit minor exchanges.

Website Beta

We continue to extend and finish all the major services we promised to release. In the Beta-phase, all previous investor will have a chance to try the product. At this time BlockFollow will only be available on the web. We will be testing the social tools, economic system, charting tools and the news and event system. In the Beta, you will be able to earn BFN by interactions, but the house income will not yet to be generated and shared.

Desktop Wallet

Simultaneously, we will be developing the desktop wallet. To get the share from the house income, you have to store your BFN in one of the wallets we provide. The first secure wallet will be released in the Q2 2018 at the same time as the Website Beta. Till then, feel free to store your tokens on the recommended ERC20 compatible wallets.

How to Participate in the pre-ICO or ICO?

If you are interested in participating in the crowdsale and don't have a wallet or don't know where to get Ethereum you can check the options below. We recommend buying Ethereum using credit card instantly on [CoinBase](#) or [CoinMama](#). If you don't have one, you can use your debit card or bank transfer. [Forbes.com also made a useful step-by-step tutorial](#) what to do to participate in an ICO. Note: you'll have to verify your identity to start purchasing Ethereum.

Exchanges

You can buy ETH on exchanges like [Kraken](#), [Bitfinex](#), [Gemini](#) or [Cex.io](#) using SWIFT / Bank Transfer. They have different fees and some of them might not be available in your country.

ETH and ERC20 Compatible Wallets

You can store both Ethereum, and BFN tokens on specific wallets. We recommend using one of these:

- [MyEtherWallet](#) (Browser Wallet)
- [MetaMask](#) (Browser Extension)
- [Parity](#) (Desktop)
- [Mist](#) (Desktop)

Buying BFN during pre-ICO and ICO

After you successfully acquired Ethereum, you have to go through an account registration and a KYC (Know Your Customer) process, to make sure, you can participate in the crowdsale according to your local laws. KYC will

eliminate the threat of identity theft, money laundering, terrorism funding, corruption or other illegal activities. This is a required step by governments, regulators, and banks as well. This will only require 3 minutes to make it as comfortable and fast as possible for our investors.

After you have passed the KYC process, we will provide you the further details (ETH address, ICO rules). The minimum amount per transaction is 0.05 ETH. Sending anything less than the minimum value can cause loss of your ETH. With the account you have created, you can purchase BFN anytime in both pre-ICO-phase and ICO-phase. Don't forget to set the gas limit to 200.000. After you have sent your ETH to the provided address, the system will automatically send you the correct amount of BFN. The transaction might take up to 30 minutes. If you didn't get your tokens, send a request to the info@blockfollow.com address.

The BlockFollow team will also provide a video tutorial and FAQ to make sure that every step is easy to understand. It will be uploaded to the website when the pre-ICO phase will begin.
